# **REGISTER.COM PRIVACY NOTICE**

Register.com knows that you care how information about you is used and shared, and we appreciate your expectation that we will do so carefully and sensibly. This notice describes our privacy policy. By visiting our Web site or by otherwise interacting with register.com, you agree to accept the practices described in this Privacy Notice. For questions on the Privacy Notice please click here.

### **What Information Does Register.com Collect?**

Here are the types of information we gather from visitors to register.com:

- Information You Give Us: We receive and store any information you enter on our Web site or give us in any other way, such as by telephone or by electronic mail. Namely, when you apply to register a domain name through register.com, we require you to provide a credit card number and billing address before we will process that application.
- <u>Automatic Information</u>: Register.com does not use "cookies." We do, however, receive and store certain types of information whenever you interact with us. For example, our servers track the type of Web browser you are using, and the page to which you link from register.com. We collect this information to better develop a sense of what services our customers need and not to track your individual usage patterns. Please note that this Agreement will become effective when accepted by register.com. Register.com may elect to accept or reject your application for any reason at its sole discretion. If your transfer request is accepted, and your domain name registration is transferred to register.com, the Services Agreement and Dispute Policy will apply to your domain name registration.

# Does Register.com Share the Information It Receives?

ICANN requires register.com to make your full name, mailing address, phone number, email address, and, where provided, your facsimile number, as well as the creation and expiration dates of your domain name registration and the nameserver information associated with your domain name, to the public via an interactive Web page and a "port 43" WHOIS service. For the purposes of this Privacy Notice we will refer to this information as your "WHOIS Information." Please note that we may not be able to control how members of the public may use the WHOIS Information.

If you have opted-into having your WHOIS Information available for bulk access, ICANN also requires register.com to make that information available to third parties who enter into a bulk WHOIS data access agreement with

Except as set out in this Privacy Notice, you will receive notice when personal information about you might go to third parties, and you will have an opportunity to choose not to have us share that information. We share personal information as described below:

- <u>Agents:</u> We engage other companies and individuals to perform functions on our behalf. Examples include processing credit card payments, providing marketing assistance, providing customer services, sending postal mail and email to you, removing repetitive information from customer lists, and analyzing data. These persons have access to personal information needed to perform their functions.
- Service Providers: We engage other companies and individuals to perform enhanced services on our behalf. For example, we have engaged Critical Path, Inc. to provide free electronic mail services to our domain name registrants and we have engaged Baltimore Technologies to provide digital certificates with register.com to our customers. In addition, certain of our enhanced services (such as Site Submit™) require that we contact Internet directories and various search engines on your behalf. Many of our service providers have access to personal information needed to perform their services.
- Business Transfers: As we continue to develop our business, we might sell or buy businesses or their assets. In such transactions, customer information generally is one of the transferred business assets. Also, if register.com, Inc. or all or substantially all of its assets were ever to be acquired, customer information will of course be one of the transferred assets.
- Protection of Register.com and Others: We release account and other

We work to protect the security of your information during transmission by using Secure Sockets Layer (SSL) software, which encrypts information you input. We reveal only the last five digits of your credit card numbers when confirming an order. Of course, we transmit the entire credit card number to the appropriate credit card company during order processing. You can further help to ensure your security by taking a few simple precautions. For instance, it is important for you to protect against unauthorized access to your register.com username and password and to your computer. Be sure to sign off when finished using a shared computer.

#### What Information Can I Access?
