AoC Reviews

The [Affirmation of Commitments](#) contains specific provisions for periodic review of four key ICANN objectives:

1. Ensuring accountability, transparency and the interests of global Internet users;
2. Preserving security, stability and resiliency of the DNS;
3. Promoting competition, consumer trust and consumer choice;
4. Whois policy.

Current Status

1. Ensuring accountability, transparency and the interests of global Internet users; **Review Team 1 launched in April, active**
2. Preserving security, stability and resiliency of the DNS; **Call for Applicants to Review Team 2 open until 15 July**
3. Promoting competition, consumer trust and consumer choice; **Review Team 3 to be launched one year after New gTLD round**
4. Whois policy.
Call for Applicants to Review Team 4 open until 15 July

Call for Applicants

ICANN invites interested individuals to apply for the position of volunteer Review Team Member.

- Call for both RT2 and RT4 applicants (launched 1 June);
- Solely intended for those who apply in representation of an ICANN Supporting Organization (SO) or Advisory Committee (AC);
- Candidatures to serve as independent experts will not be considered;
- Membership in more than one RT discouraged.

RT2 - Security, Stability and Resiliency

Selection and Composition

Among applicants supported by SOs and ACs, the GAC Chair and ICANN's CEO will select:

- 2 from GAC (including the GAC Chair or Chair's representative)
- 2 from GNSO
- 2 from ccNSO
- 2 from ALAC
- 1 from SSAC
- 1 from RSSAC
- 1 from ASO
- ICANN CEO
- Plus 1-2 independent experts

RT4 - WHOIS Policy

Selection and Composition

Among applicants supported by SOs and ACs, the GAC Chair and ICANN's CEO will select:

- 4 from GNSO
- 1 from ccNSO
- 1 from ALAC
- 1 from SSAC
- 1 from ASO
- GAC Chair or Chair's representative
- ICANN CEO
- Plus 1-2 independent experts (law enforcement / privacy issues)

Launch dates - and deadlines!

- RT2 shall be launched before 1 October 2010 and conclude its work by Q3 2011
- RT4 shall be launched before 1 October 2010 and conclude its work by Q3 2011
