Article VI. - Executive Council

The Executive Council shall consist of the present [ISOC HK] officers, the chairmen of the Chapter's standing committees and other individuals invited by the standing Executive Council and/or the Members-at-large. Invitees potentially include the immediate Past Chair and other relevant or respectable individuals.

The term of the members of the Council shall coincide with the terms of the officers. They shall take office on the first day of the fiscal year and serve for one year.

A resolution of the Executive Council must be carried through with a majority vote between the present Council members forming a quorum. A quorum of the Executive Council requires at least the presence of 5 standing Council members.

#### Article VII. - Standing Committees

- A) General Program & Membership Committee
- B) Outreach & Education Committee
- C) International Relations Committee
- D) Special Programs Committee

#### Article IX. – Meetings

- 1. [ISOC HK] shall hold meetings only in places (including via the Internet or telephone conference facilities) that are open and accessible to all members of the Society. Meetings shall be held as planned by the General Program & Membership Committee.
- 2. An Annual General Meeting shall be held at least once within a fiscal year of the Chapter, towards the end of the period. At this meeting, the Secretary and Treasurer each shall present a report. Also, the election of officers, whose term will be expiring, shall be held and results announced by the Chair.
- 3. Notices of the place and time of all meetings shall be distributed to all members at least one week prior to any meeting, by Internet mail or by oral, telegraphic, or other written notice, duly served on or mailed.
