# 2011 Nominating Committee Selection (1)

- **Initial Meeting:** 10 - 12 December 2010, Cartagena, Colombia
- **10 Teleconference calls:** January 2011 – June 2011
- **Phase 1:** Outreach from December 13, 2010 to April 4, 2011:
  - various events (Geneva, Brussels, Hong Kong and San Francisco)
  - additional recruitment of Board candidates by professional recruiting firm, outcome not satisfactory
- **Nomination period for SOIs:** December 17, 2011 - April 4, 2011





# 2011 Nominating Committee Selection (2)

- **Phase 2:** Evaluation from 4 April
  1. committee database and evaluation tool for initial review of candidates
  2. 25 Director candidates selected for interview by professional assessment firm (Odgers Berndtson)
  3. Parallel reviews and assessment of references, other information
  4. ALAC, GNSO, ccNSO deep dive and identification of top candidates
  5. Director candidate interviews in Singapore: all NomCom plus 11 ( 8 face to face and 3 video conference)
- **Phase 3:** Final selection meeting in Singapore, June 24 – 26, 2011
  - Due Diligence: July 2011 (NomCom questions need for due diligence of SO/AC selected nominees)
  - Announcement: August 5, 2011
  - Successful Candidates seated: Dakar, Senegal Annual Meeting
