A rundown of the latest IDNA protocol for handling non-ASCII characters in domain names.

Anyone wishing to interact with Internationalized Domain Names will need to understand the revised protocol.

1pm: Translation Programme Utrillo

This meeting will outline the organization's new programme for making information available in other languages.

ICANN is just embarking on a structured translation programme and needs community feedback and assistance.

Anyone interested in seeing ICANN produce material in languages other than English is welcome.

4pm: Board meeting Utrillo

The public meeting of ICANN Board of Directors.

The Board is the ultimate decider of ICANN's work. As such, the concrete and lasting outcomes of the conference will be approved in a series of resolutions during this meeting. The Board will also review and discuss the work that has occurred during the week.

The manager for Costa Rica's top-level domain, .cr, signed an accountability framework with ICANN, making it the ninth agreement signed in the region.
