 - —Tell how will you will comply
 - Outline provided for what a complete answer should include
 - Additional guidance for extra points (limited)



Questions by section

- Public facing questions: Qs 1-30a
 - Focused on who you are, registry service, and type of string
- Internal facing questions: Qs 30b-50
 - Focused on operations and financial support



Questions 1-12

- Applicant information
- Application contact information
- Proof of legal establishment
- Background
- Evaluation fee



Questions 11 - Applicant Background

- Background screening
 - Strong presumption of failing background screening process if any conviction of crimes listed in question 11e
 - i xii of the questionnaire
 - For both the entity applying and key individuals listed in the application



Questions 11 - Applicant Background

AGB Section 1.2.1

"For example, a final and legally binding decision obtained by a national law enforcement or consumer protection authority finding that the applicant was engaged in fraudulent and deceptive commercial practices as defined in the Organization for Economic Co-operation and Development (OECD) **Guidelines for Protecting** Consumers from Fraudulent and **Deceptive Commercial Practices** Across Borders8 may cause an application to be rejected."



ICANN reserves the right to deny an application if during the background screening other issues come to light

Questions 13-17: Applied-for gTLD String

- gTLD string (Q 13)
- IDN yes or no (Qs 14-17)
 - IDN tables for applied for language or script
 - IDN table for each language or script to be offered at second level
 - Currently, no variant gTLD strings will be delegated through the program



Question 18: Mission/Purpose

- Description of purpose of registry must be sufficiently detailed to enable comment
- If community, this description must be consistent with question 20



Question 18: Mission/Purpose

- There are two economic benefit questions
 - —How will your proposed new gTLD benefit registrants, Internet users and others?
 - —What operating rules will you adopt to eliminate or minimize social costs?
- Answers are primarily to enable program review after launch



Questions 19-20: Community-Based Designation

To elect or not to elect

- Will provide preference if there is a contention set
- Community status cannot be changed
- Post-delegation contractual obligations shall reflect commitments to the specified community



Questions 21-22: Geographic Names

- Government endorsement required for:
 - Any cities or sub-national place names listed in ISO3166 1 or 3166-2
 - A continent or UN region as represented on specified lists
 - If TLD is to be "used for a specific purpose associated with a city name"
- Documents of support or non-objection required from relevant governments or public authorities
- Process and policies for protection of geographic terms at second level required, including incorporating GAC advice



Question 23: Registry Services

All remaining answers (Qs 24-50) should align with the proposed Registry Services captured in



- Security, stability & registrant protection paramount
- If the proposed registry service requires further analysis then Registry Services Technical Evaluation Panel (RSTEP)
 - Requires an additional fee

Questions 24-44: Technical & Operational

Questions cover external facing processes (Qs 24-38) and internal infrastructure (Qs 30b-44)

- External facing will be posted and open to application comments
- Currently: 30 points available; 22 points required to pass
 - Ten questions provide for extra points



Questions 28-29: Abuse Prevention & RPM

- Mandatory:
 - Single point of contact for abuse
 - Sunrise, IP Claims, implementation of decisions under URS and UDRP
- Extra points for measures to promote Whois accuracy
- An extra point is awarded if RPM is a core objective

Question 30: Security

"Calls for security levels to be appropriate for the use and level of trust associated with the TLD"

- Specify commitments made to registrants concerning security levels
- Extra points awarded for an independent report stating effective security controls



Questions 31: Technical Overview of Proposed Registry

- Tells high-level story of the technical and operational aspects of the registry
- Description of outsourcing plans



Questions 45-49: Financial Capability

- Funding must cover technical and operational requirements
- Mandatory provision of audited financial statements (balance sheet, income statement, statement of shareholders equity/partner capital, and cash flow statement) or unaudited statements if new
- Complete a Projections Template and describe basis & rationale for assumptions
- Assimation that funding and revue projections are simple that with other public/private claims

Question 50: Critical Registry Operations

- Requirement: Irrevocable Letter of Credit or an irrevocable cash escrow sufficient to cover critical registry operations for three years
 - 1. DNS resolution for registered domain names
 - 2. Operation of the Shared Registration System
 - 3. Provision of Whois service
 - 4. Registry data escrow deposits
 - Maintenance of a properly signed zone in accordance with DNSSEC requirements
