Michele Neylon: Good morning, everybody. Please take your seats. And this is the Registrar Stakeholder Group Meeting. If you are not a - if you're not looking for this

meeting, please go and find your meeting.

Okay, so I think we'll kick this off. Good morning everybody and welcome to Dublin. And if there are recordings and other things that need to happen in the background, please start them off.

Thank you. Welcome to Ireland, which is my home, yay. And so this time, as you can imagine, this was a very hard trip for me. I've spent many hours on trains and planes to get here.

And, okay, so the schedule for today is a little bit different to what we've had at other meetings because we're combining with the registries for part of the day. And I'm going to hand over to - Darcy, I think, will explain some of that in more detail.

For all the people I know joining us that is, I think, some of you may have been out last night, possibly. So I'm going to hand over to Darcy who will explain a little bit about the agenda and our general movements this morning.

Just to explain a bit as well a part of the reason why we're joining with the registries for some of this -- what we've been - what we've seen over the last couple of meetings is that many of the issues that we wish to raise with the GDD staff overlap with what the registries wish to raise with them.

So rather than having two short meetings that don't really accomplish a huge amount, we thought we'd make more sense to have one meeting and accomplish a little bit more. Okay then. So, also as well, on the - you all should have a copy of the agenda which was sent to you via e-mail with some details of what we're going to be covering in the close sessions later today.

And if anybody has any questions or queries about that, please do let us know. What else do I need to tell you? The several people here - I think it's probably your first ICANN meeting - welcome. For some of you, it's also your first meeting within the registrar stakeholder group.

And just to explain to those of you who are not familiar, so you have - as a registrar stakeholder group, you have an ExCom, which is a chair -- that's me, hi -- a vice-chair who is, well, as we like to call him, our Vice-Chair elect because he's not officially the Vice-Chair but is kind of officially the Vice-Chair because of the election cycle.

Darcy is our secretary and Paul Goldstone is the Treasurer and has also been - also looks after the websites for a variety of different reasons. We also have three GNSO counselors -- James Bladel - make yourself known, James

has put up his hand - Volker Greimann, who I don't see in the room. And the third counselor is Jennifer Standiford.

Go ahead, James.

Yes, actually Yoav is our third counselor until tomorrow, and then he'll because of his term limits, he'll leave and step down and then our counselor elect is Jennifer Standiford from Web.com.
