- The zone files for .se and .nu are available since 2016-05-16!
- Available through HTTPS and AXFR, no restrictions

- A year ago, discussions on the transition from NSEC to NSEC3 at a IIS DNS Reference Group meeting
 - It's relatively hard to make this transition
 - Why is the zone content considered to be secret?
 - The DNS Reference Group asks IIS to consider the possibility to release the .se zone file

Wistrand

- Check agains the Law on Top Level Domains in Sweden (prop 2004/05:175).
- Check against the Personal Data Act (prop 2005/06:173).

 - "Your registrar can help you with this"
