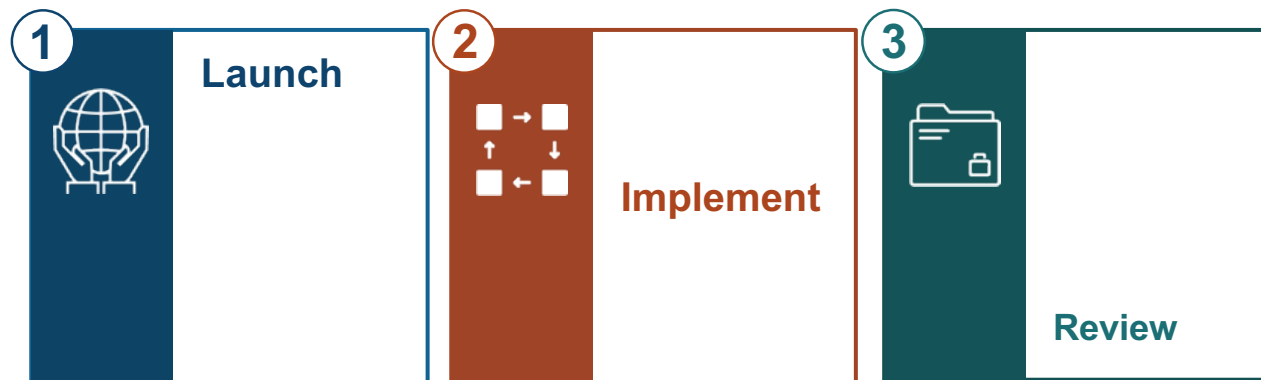

## An Evolving Document...

---

The Africa Strategy remains a living document, with regular reviews to keep realigning it not only to the ICANN Vision and Mission, but most importantly, to the ever evolving community needs and realities on the ground.



For example, ICANN org has undergone important transformations in the last 3 years such as the IANA stewardship transition (Oct 2016) ICANN.

- **1st Review held in November 24-25, 2014: Mauritius**

**2<sup>nd</sup> Review meeting held in July 2, 2018: Cotonou Benin:**

**On July 30, 2018, we published the revised draft ICANN Africa strategic plan FY16-20 Ver 3.0 for public comments.**

## Key Outcomes of the 2<sup>ND</sup> Review Meeting (July 2<sup>nd</sup> 2018) which have informed the Objectives of the Draft Strategy Ver3.0

- ⦿ The group reiterated that the Africa Strategy document is a strategy for ICANN by Africa, but Africa must also fully take its ownership. It was also highlighted that this strategy is merely dealing with the DNS industry, and hence does not cover the entire Internet ecosystem in Africa.
- ⦿ There should be renewed focus in promoting Capacity Building initiatives that would ensure Africa as a community fully and effectively participates in the ICANN ecosystem.
- ⦿ Going forward, more attention and resources should be dedicated to quality of the participants and not necessarily quantity.
- ⦿ In regard to the DNS industry, the group proposed that ICANN should have a differentiated approach to Africa owing to its uniqueness and in the spirit of public interest.

## Cont...

- ⦿ There needs to be additional focus on mentoring the youth with increased outreach to youth and academia.
- ⦿ ICANN should also tap in the diversity of fellowship alumni and ccTLDs and leverage them to further support engagement in their various countries and activities.
- ⦿ While it remains imperative to have a balanced approach to engaging all the relevant stakeholders in Africa since they possess different strengths, not everybody maybe relevant or interested.
- ⦿ There still exists very little business community involvement. We need to find out why.
- ⦿ Lastly, it is also important to appreciate the progress made so far in the overall DNS and Internet ecosystem in Africa, i.e. today we have many functional REN, increased number in ICANN accredited registrars, and overall ICANN visibility across Africa.

## Highlights from the Public Comments

---

- ⦿ At the close of the public comment period, seven comments were received, three of which were submitted by individuals while another four were submissions on behalf of ACs / SOs (ALAC, BC, NSSG, RySG)
- ⦿ Low quantity of comments received, but underscore and thank the community for the quality of the responses in general.
- ⦿ Most of the comments urged us to ensure balanced Engagement and closer collaboration with all SOs / ACs
- ⦿ There were also suggestions that we include more details especially in terms of KPIs and actual budget projections for the listed projects in subsequent Operational Plans.
- ⦿ It was recommended that African participants should strive to organize subgroups within each of the SOs/ACs so that a continental view or opinion should be better elaborated and shared as African contribution to policy development within ICANN

## Refined & reviewed list of Ten Objectives

---



- The overall outcome was a re-evaluation of the current strategic objectives.
- The team arrived at the conclusion that majority of the current objectives were indeed still valid and good for Africa.
- Two new objectives (9 & 10) were formulated.
- And a final list of 10 objectives were agreed by the review team. (Please refer to page 8 and 9 of the report.)
