## About EU initiatives - DSA and NIS2

## About the CoE Second Additional Protocol to the Convention on Cybercrime

 <u>Blog</u>: Feedback on the Second Additional Protocol to the Convention on Cybercrime, 23 April 2021

The blog highlights that the Council of Europe (CoE), in the context of its proceedings in the preparation of a draft Second Additional Protocol to the Convention on Cybercrime, is considering draft provisions regarding domain name registration information. It informs the community that the latest draft version of the Protocol is open for feedback and that the CoE is planning an online stakeholder consultation meeting which is open for registration. It finally notes that ICANN org has participated in previous consultations during the drafting process of the Second Additional Protocol within the context of the CoE Octopus Conferences, providing information on the work of ICANN's community.
