CRISP Team: RIR Communities

- 15 members: 3 each RIR, 2 from the community and 1 from Staff
- RIPE NCC, AFRINIC, APNIC, ARIN and LACNIC
- 1 Chair and Vice Chair
- Each RIR Community developed its own appointment process for CRISP members

Process followed by CRISP team

- From 9th December until 15th January
- Consolidate one single proposal after regional debate (Global Process)
- 14 CRISP Teleconferences Open to observers
- 2 draft (19th December and 8th January)
- <u>ianaxfer@nro.net</u> Mailing list for global discussions
- 24 hs window was set for decisions
- Final proposal submitted to ICG on time!

Proposal's Main Points

- ICANN to continue as the IANA Numbering Services Operator
- IPR related to the provision of the IANA services remains with the community
- Service Level agreement with the IANA Numbering Services Operator
- Establishment of a Review Committee

ICANN to continue as the IANA Numbering Services Operator

- Numbers community are satisfied with the performance of ICANN in the role of IANA numbering services operator
- Minimal changes in existing arrangements, RIRs delegate to a particular IANA function operator → Replacing NTIA
- No impact on policy development

IPR related to the provision of the IANA services remains with the community

- IANA trademark, IANA.org domain name and public databases including IANA Numbers Registries.
- Public Domain for Registries and RIRS for non public information.
- IANA trademark and IANA.org transferred to an entity independent of the IANA services operator → IETF TRUST
- Ensures that these assets are used in a nondiscriminatory manner for the benefit of the community.

Service Level agreement with the IANA Numbering Services Operator

- New contract between IANA numbering services operator and the 5 RIRs.
- Excluding NTIA and including RIRs as the stakeholder
- Establishing specific requirements for performance and reporting
- Consequences for breaching requirements and means for disputes resolution
- Proposal includes general principles for the SLA

Establishment of a Review Committee

- Inspired in MONC (Multistakeholder Oversight Numbers Council) proposed by LACNIC's community
- To ensure that the service level agreement is maintained by the IANA numbering services operator
- The Review Committee shall be established by the RIRs and will advise the NRO EC in its periodic review on SLA
- Its scope is limited to processes followed by the IANA numbering services operator
- Equal representation from each RIR region, qualified communities' representatives.

Conclusions -Next Steps

- Consent reached within the numbers resources community for IANA stewardship transition.
- Proposal addresses each NTIA's requirements
- Timeline was accomplished
 Now:
- Wait for ICG feed back and name community proposal (expected June 15)
- Go forward with proposal details: i.e.: review committee conformation, specific SLA terms and conditions, etc.
