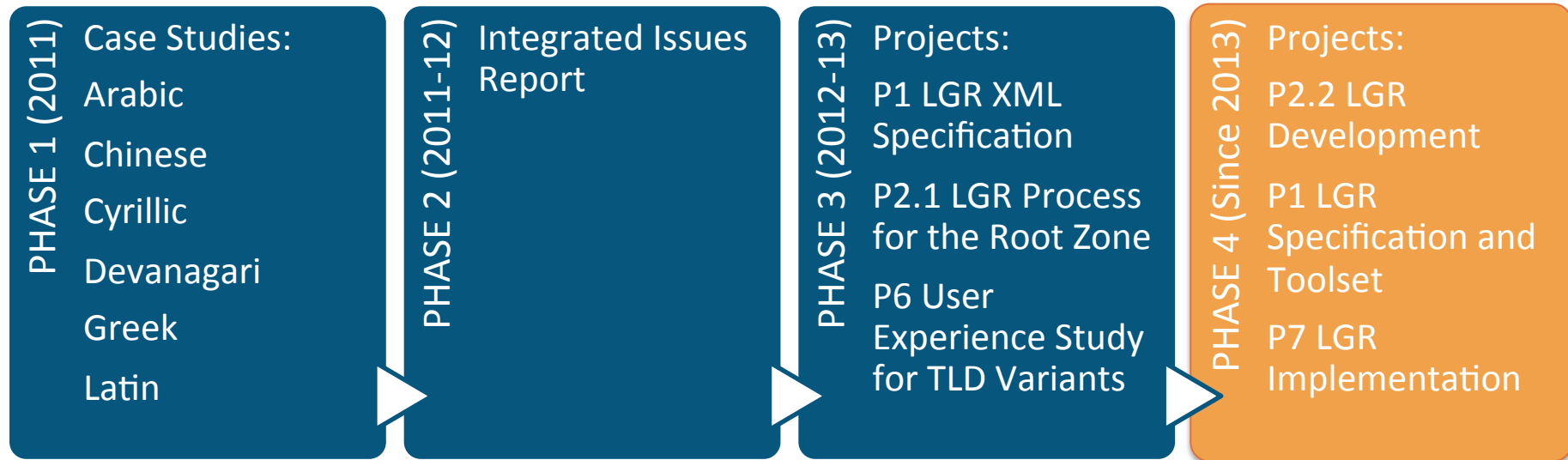

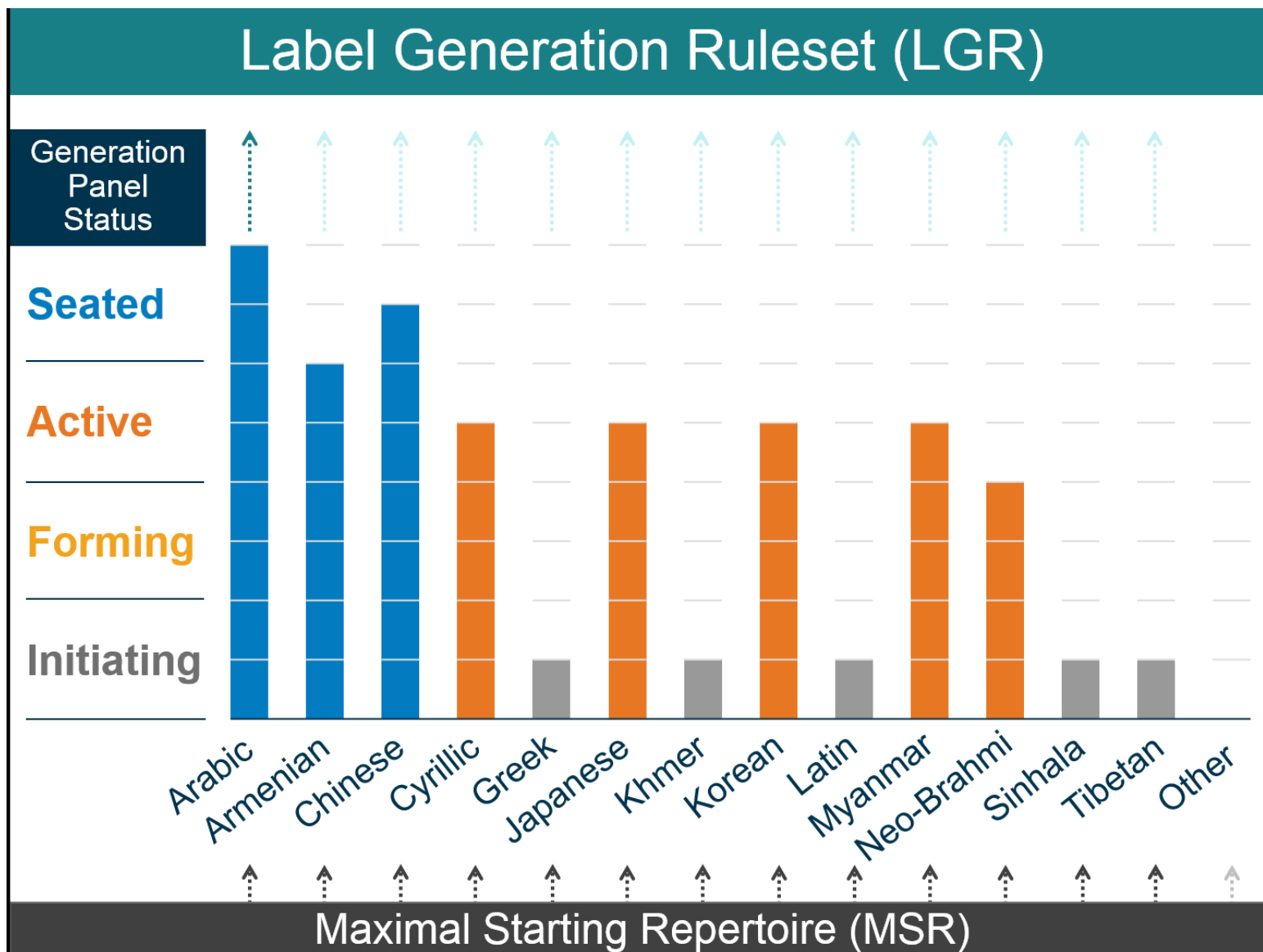
Work Under IDN TLD Program

Status of Generation Panels



Maximal Starting Repertoire – Ver. 2 (MSR-2)

- ⦿ MSR-2 released for public comment :
<https://www.icann.org/public-comments/msr-2014-12-15-en>
- ⦿ Upwardly compatible replacement for MSR-1
- ⦿ Total 28 scripts
 - ✧ Six new scripts added
 - ✧ Armenian, Ethiopic, Khmer, Myanmar, Thaana, Tibetan
 - ✧ Existing scripts in MSR-1 unchanged

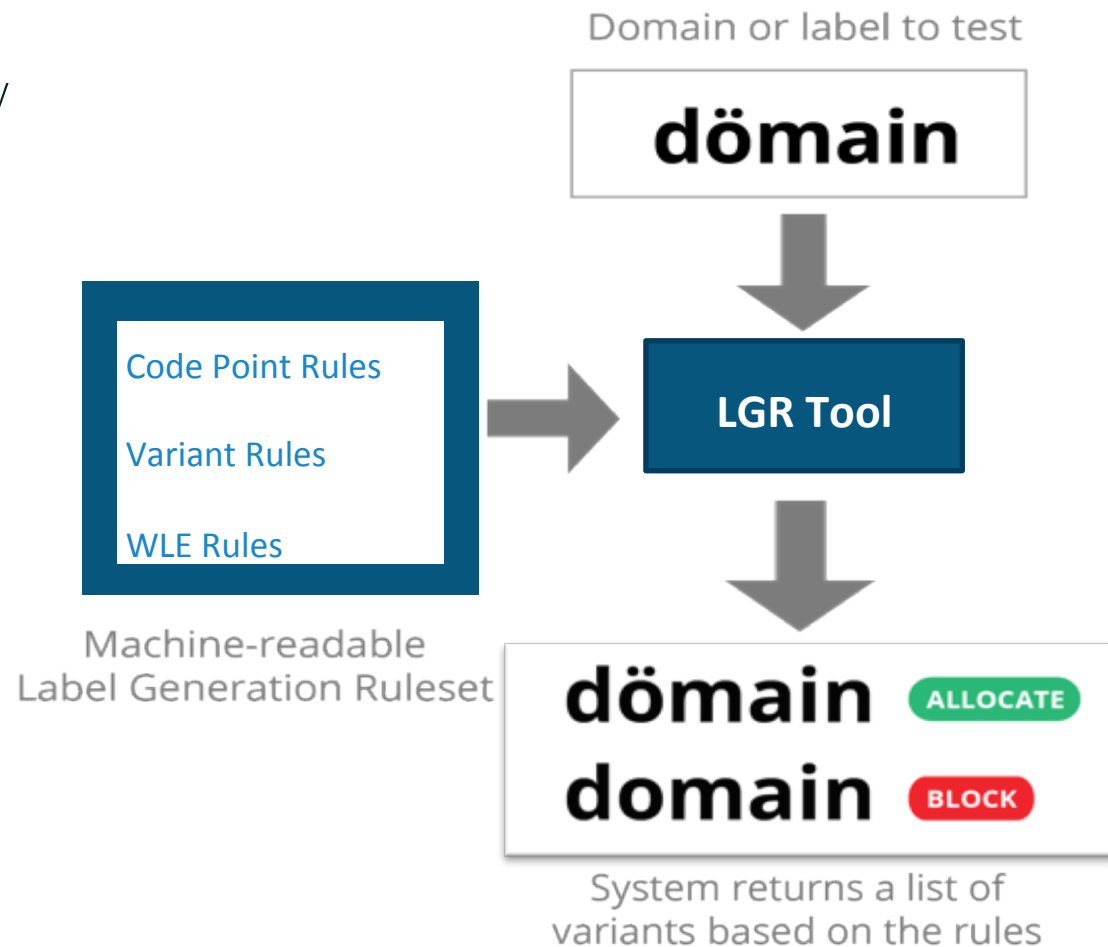

- ◉ Open source

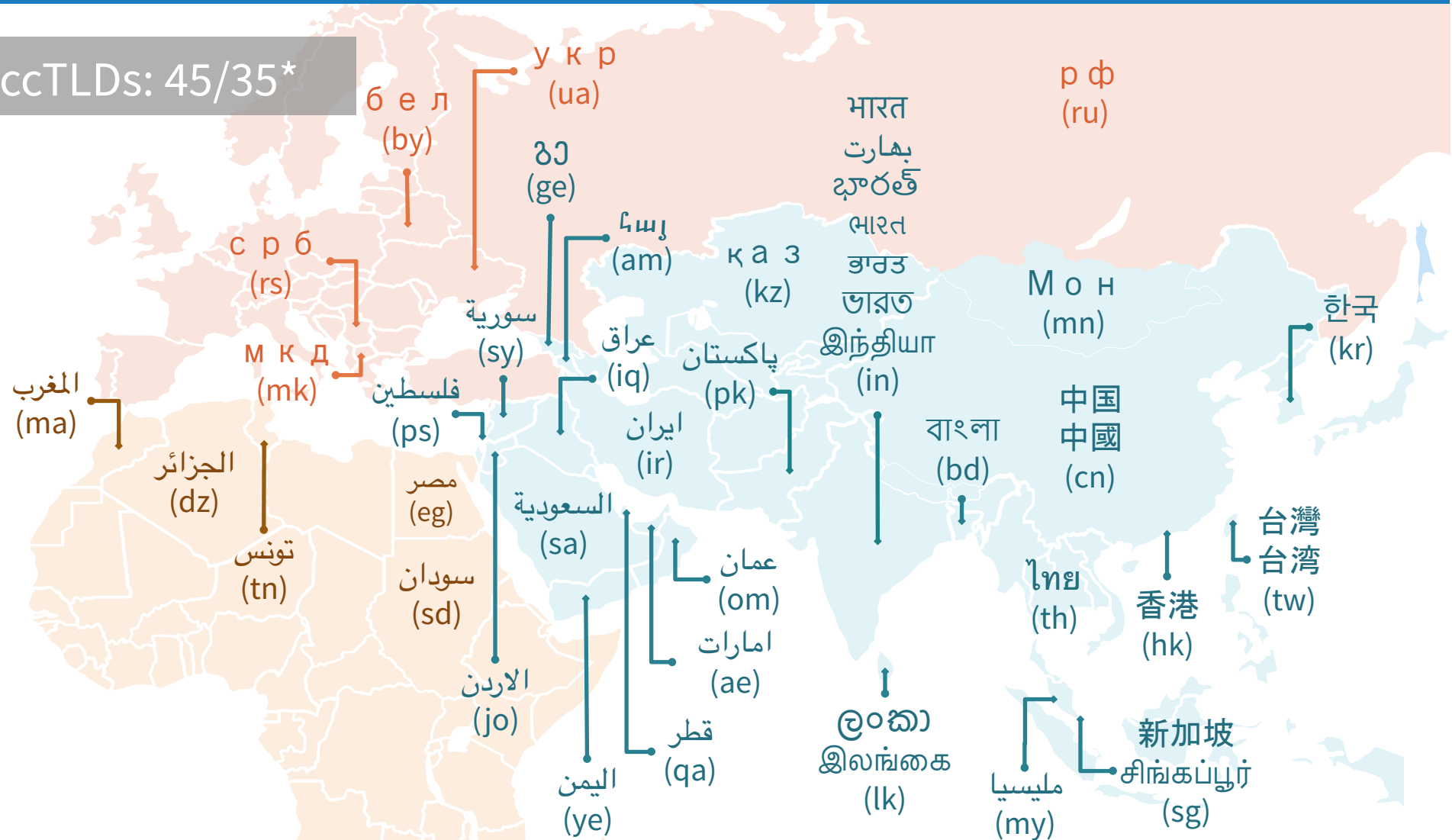




IDN ccTLD Fast Track Process

Status of IDN Country Code TLDs

ccTLDs: 45/35*



* Successfully evaluated IDN ccTLDs/Total countries/territories

Overview of IDN ccTLD Fast Track Process

- ◉ Completed five years of operation
- ◉ Requests in 17 scripts for 26 languages
- ◉ 38 IDN ccTLDs delegated in the Root Zone representing 28 countries/territories
- ◉ Following ccNSO recommendation, a two-panel string similarity review process was implemented in December 2013
 - ◉ The Extended Process Similarity Review Panel (EPSRP) published results of the first set of evaluations in Oct. 2014:

IDN Tables

- ⦿ Submitted by new gTLDs intending to offer IDNs
 - ⦿ Varied in the character repertoire and contextual rules
- ⦿ Develop reference Label Generation Rulesets (LGRs) for facilitation and consistency in Pre-Delegation Testing (PDT) and the Registry Service Evaluation Process (RSEP)
- ⦿ Promote reuse for better end-user experience
- ⦿ Process:
 1. Develop detailed guidelines
 2. Document authoritative sources and create reference machine-readable LGRs
 3. Conduct expert review of LGRs for content, security and stability
 4. Publish LGRs, authoritative sources and expert reports for each language/script for community feedback
 5. Publish updated reference IDN Tables

Status of IDN Implementation Guidelines

- ⦿ Last updated in 2011
 - ⦿ New IDN terminology due to IDN Variant TLD projects
 - ⦿ Consistent, machine readable format for language tables
 - ⦿ Updated content: IANA IDNA table with Unicode versions, MSR, LGR
 - ⦿ Additional guidelines: informational RFC 6912, User Experience study
- ⦿ **Current status - awaiting community response on list of issues**
 - ⦿ Letters written to ccNSO and GNSO chairs – 4 Dec. 2014

- ⦿ **Continue communication and outreach efforts**
