

- + As of 5 April 93 passing of first 108 applications
  - First 108 applications includes prioritized IDNs
  - Results for 15 applications not yet available
  - Possible reasons include: pending change requests, clarifying questions, or follow-up with applicants regarding missing information.

## Objections & Dispute Resolution



- + 274 Objections submitted / 220 Objections validated to date:
  - 33 String Confusion Objections
  - 69 Legal Rights Objections
  - 23 Limited Public Interest Objections
  - 95 Community Objections
- Objection filings that comply with the Applicant Guidebook will be posted on the Dispute Resolution Service Providers (DRSP) websites.
- + Formal notifications will be sent to Applicants and Objectors after the release of the Dispute Announcement on 12-April-2013.
- Applicants will have 30 days to respond after notification is received.
  - If fees and responses are not filed by the Applicant, the Objector will prevail by default.

## Registry Agreement & Public Interest Commitments

- Revised Registry Agreement & Public Interest
   Commitment published 5 February
- PIC Specs solicited from applicants through
   5March
- + 506 PIC Specs received and posted from Applicants
- + Public comment period closed 17 March
- Agreement discussions ongoing
- Updated agreement posted 2 April for public review and discussion during Beijing meetings





## Contracting Phase: Registry Agreement Eligibility

- Applications eligible for Contracting: Passed Initial Evaluation, no pending objections/GAC advice, and not in string contention.
- + Receive formal notification to begin the process.

  Receive Contracting Information Request, including:
  - Continued Operations Instrument (COI) documentation
  - Contact and signatory information
  - Cross-ownership declaration
  - Indication of acceptance (or not) of base registry agreement
- + Applicants accepting the base registry agreement will be processed rapidly; applicants seeking to negotiate will require more time.





## Pre-Delegation Testing Pilot Update

- + 12 Pilot Participants Selected.
  - Over 80 Applicants volunteered over 140 Applications.
  - 1 Participant per volunteered Registry Service Provider.

- PDT System user guide to be made public by 17 April.
- Materials will be finalized by 17 April based on Pilot lessons learned.
  - Changes expected to primarily be enhancements to the instructions documents.
- PDT Session planned for Beijing: Focus on preparing applicants for successful PDT.

## Uniform Rapid Suspension (URS)

- National Arbitration Forum (NAF) announced as first URS provider
- April Supplementary Rules to be published
- April Additional provider(s) to be appointed
- April to June System details published (announcement page, interfaces, verification)
- July System launch and demonstration
- Verification of each registry's operational readiness for URS



# Post Delegation Dispute Resolution Process (PDDRP)

#### 3 PDDRPS:

- Registry Restrictions
- Trademark
- Public Interest Commitments

- PIC DRP Specification has been published
- + RFPs to be issued for provider selection
- To be operational for first operational new gTLD



## **Operational Support Mechanisms**

- Data Escrow
- + SLA Monitoring
- + Centralized Zone Data Access
- + Emergency Back-end Registry Operator (EBERO)



## **SLA Monitoring**

- Registry Monitoring Platform in development with partner Zabbix SIA
- Monitoring nodes across all ICANN regions
- + August Release 1
  - + Full DNS testing operational
  - WHOIS and EPP tested using standard
     TCP port test
- + October Release 2
  - + Full EPP testing operational
  - + Full WHOIS testing operational
  - + Full correlational testing operational



## Centralized Data Access

- Request from zone data consumers
- Model developed by community of registry operators and security experts
- A new model for zone file access that can scale with the number of new gTLDs
  - A central point of access
  - Data delivered in standardized, consistent format
- + Projected launch date June 10th



# Emergency Back End Registry Operator (EBERO)



- + Providers selected and announcement 2 April
- + Program active in August 2013
- + Next steps:
  - Contracting
  - Process Workshop finalize details
  - Testing and Simulation
