## Scope of Framework

• Applicable policy and guidelines: RFC 1591 and GAC-Principles 2005

- Framework for interpretation adding colour and depth to existing policy and guidelines
- Not in scope

•Changing applicable policy or guidelines

 The IANA Functions contract, including contract implementation issues or procedures

## Process for topics

• WG prepares draft set of interpretations for a topic in an Interim Report (Example: Consent report).

- WG undertakes a public consultation of the draft set of interpretations.
  - •WG reviews comments and input from the public consultation.
- WG prepares a Final Report of interpretation for a topic.

# Process for topics (cont'd)

• GAC and ccNSO support for Final Report - BOTH communities have to support report

- Submission of Report to the Board by chair of the ccNSO, includes:
  - Confirmation of support by GAC and ccNSO
  - Report with recommendations

### Topics for interpretation


Consent for delegation and re-delegation requests

- Support for delegation and re-delegation from Significantly Interested Parties (LIC)
- Recommendations for un-consented re-delegations
- Comprehensive glossary
- Recommendations for IANA reports on delegation and re-delegation

## Activities since Singapore

• The working group met by teleconference 9 times since the Singapore meeting.

- Has updated its charter and work plan
- Has published a progress report on its activities since Singapore
- Has published a public consultation on Consent.
- Is currently working on the topic on Significantly Interested Parties.



## **Terminology Topic**

 The objective is to develop a comprehensive glossary of terms used in context of delegation and redelegation of ccTLDs.

 WG concluded that it would be more effective to evolve the glossary in parallel with other work. Terminology topic has been moved to the end of schedule.

# Consent Topic (1)

• The objective was to develop guidelines as to how IANA should obtain and document consent from the proposed manager for a ccTLD delegation and from the proposed and incumbent managers for a re-delegation.

 The working group completed its initial work on the Consent topic in September and results are included in Interim Report which is currently the subject of a public consultation. See: <u>http://www.icann.org/en/announcements/</u> <u>announcement-12oct11-en.htm</u>.

## Consent Topic (2)

• Input and comments on Interim Report are taken into consideration by the participants in the WG.

- Based on input and comments the WG will prepare a Final Report
- Final Report on Consent will be published prior to the Costa Rica meeting

 At the Costa Rica meeting: Seek support from GAC and ccNSO on recommendations on obtaining and documenting consent

#### Valid Manager, AC and TC Topic

• No need for the Valid Manager, Administrative Contact and Technical Contact topic.

 FOIWG has proposed that only the manager approve the delegation and that only the incumbent and proposed managers approve a re-delegation
No change of project plan.

#### Significantly Interested Parties (SIP)

• The objective is to develop guidelines as to how IANA should obtain and document support for delegations and re-delegations from significantly interested parties as defined in RFC1591.

• It is expected that the working group will complete its initial work on this topic and publish Interim Paper prior to Costa Rica meeting.
