Negotiations

- 18+ extended negotiation sessions
- Includes proposals from LE, GNSO/ALAC RAA-DT, Registrars & ICANN
- ICANN's posted RAA draft and Registrars' posted summaries are *not* negotiated documents
 - Many areas of agreement
 - Differences in key areas



Status of LE Recommendations

4 key LE recommendations to highlight:

- WHOIS Validation/Verification
- Registrant data collection/retention
- Resellers and Privacy/Proxy provider obligations
- Abuse point of contact



Key GNSO Recommendations

Much overlap with original LE proposals

- Enhanced collection of registrar and affiliate information
- WHOIS SLA -Port 43 availability
- Prohibition against cybersquatting
- Registrar responsibility for acts of affiliates



Key Registrar Proposals Considered

- Align terms for amending and renewing the RAA with new gTLD registry agreements
- Removal of Port 43 Whois obligations for "thick" gTLDs (duplication of registry data)
- Align Consensus Policy section with new gTLD registry agreements - keep "picket fence"
- Streamline automatic accreditation in all new gTLDs



Key ICANN Proposals Considered

- Improved termination and compliance tools
- Streamlined arbitration
- Requirement to implement IPv6, DNSSEC and IDN protocols
- Sunset/revocation provision

Whois Data Verification

- What verification should occur?

Phone Verification

- What are impacts to registrants?
 - Required to have phone numbers?
 - Language Issues?
- Technical burdens for Registrars?
- Encourage the use of proxy services?
- What goals are achieved through phone / SMS verification?



Timing of Verification

- When should information be verified?
- Before the domain name resolves:
 - Should phone numbers be verified?
 - Should emails be verified?
- Change to registrant expectations today?



Annual Re-verification

- Burden on legitimate registrants?
- Possible unintended consequences?
- Technical burdens for Registrars?
- What additional goals will be achieved?
- Are the goals proportional to burdens?



Whois Data Verification

- What verification should occur?
- Timing of verification?
- How will the current marketplace user/registrant experience change?
- What goals are achieved through heightened verification?



Data Retention

- Duration proportionate with LE objectives?
- Burden on registrant privacy rights and Registrars?
- Compliance concerns if illegal for Registrars?
 - Process to permit registrars to remain compliant with law?
- GAC views on latest LE clarifications?
- Input from data privacy authorities?



Options for Universal Adoption

- Begin limitations on accreditations/renewal terms to allow all registrars to adopt together
- Creating milestones for phasing in certain terms
- Incentives for early adoption of the new RAA
- Registrar Code of Conduct process
- Use of the new agreement for new gTLDs
- Others?



Next Steps

- Community consultations in Prague and thereafter
- RAA negotiations continue after Prague, after and while receiving input from community
- Fully negotiated RAA to be published for public comment
- ICANN Board Approval
- GNSO PDP on “remaining issues” for amendment process to commence if necessary?
