## 1. Confirmation of Approval of Minutes and Actions 1 March 2011

## 2. Delegation & Re-delegation Working Group Report

### *Background*

The DRDWG has submitted its Final Report to the ccNSO Council in February 2011 and published it for public comment. At closure of the Public comment period, 15 March 2011, no comments were received.

The DRDWG has recommended the ccNSO Council undertake, as a first step, the development of a "Framework of Interpretation" for the delegation and re-delegation of ccTLDs. This framework should provide a clear guide to IANA and the ICANN Board on interpretations of the current Policy Statements.

The DRD WG recommended further that the results of the use of such a Framework of Interpretation should be formally monitored and evaluated by the ccNSO Council after a pre-determined period. If the results of this evaluation indicate that the Framework of Interpretation has failed to provide logical and predictable outcomes in ICANN decision-making, the ccNSO Council should then launch PDPs on the delegation and re-delegation of ccTLDs.

Finally, the DRDWG has recommended that the ccNSO should request an Issues report to launch a cc Policy Development Process on the retirement of ccTLDs ( in accordance with section 1 Annex C ICANN Bylaws). At the same time the DRDWG advised that the Council consider the development of a Framework of Interpretation as a higher priority than the ccPDP for retirement of ccTLDs

### *Resolutions*

1. The ccNSO Council acknowledges receipt of the Final Report of the DRD WG and notes that according to its charter the DRDWG is closed.
2. The ccNSO Council warmly thanks all members, experts, observers on the DRDWG for their outstanding work, and timely delivery of the Final Report
3. The ccNSO Council resolves to create the Framework of Interpretation Working Group (Fol WG) as recommended and in accordance with the proposed charter. The objective of the WG is to develop and propose a "Framework of Interpretation" for the delegation and re delegation of ccTLDs. This framework should provide a clear guide to IANA and the ICANN Board on interpretations of RFC 1591, ICP-1 and GAC Principles (Policy Statements).
4. The ccNSO Council appoints Keith Davidson as Chair of the WG
5. The ccNSO requests staff to send out a call for volunteers in the usual manner.
6. The ccNSO Council will revisit whether or not to request for an Issues Report to launch a ccPDP on the retirement of ccTLDs in accordance in Annex B of the ICANN Bylaws, at the time the Fol WG has submitted its Final Report as foreseen in the charter of the Fol WG

### **3. Fast Track review**

#### *Introduction*

During the ccNSO meeting the results of the review process of the Fast Track were presented and issues discussed, in particular the issues pertaining to confusable similarity. The meeting welcomed an initiative to seek further clarity and assistance for current and future IDN ccTLD Fast Track applicants regarding the confusingly similarity evaluation.

#### *Resolution*

The ccNSO council requests IDN ccPDP WG1 to, as soon as possible, develop guidelines (within the framework of the existing rules for the Fast Track) to attempt to reduce the possibility of unexpected outcomes from the technical evaluation process relating to the confusing similarity test as defined in the IDNC Final Report and the Final Implementation report as adopted by the ICANN Board in November 2009.

#### *Background*
