SPECIFICATION 3

FORMAT AND CONTENT FOR REGISTRY OPERATOR MONTHLY REPORTING

Registry Operator shall provide a monthly report to registry-reports@icann.org with the following content. ICANN will use reasonable commercial efforts to preserve the confidentiality of the information reported until three months after the end of the month to which the report relates.

- **1. Service Availability Performance.** Compare DNS and WHOIS service availability performance against service availability Performance Requirements for the reporting month
- **2. Per-Registrar Activity Report.** This report shall be transmitted to ICANN electronically in comma or pipe separated-value format, using the following fields per registrar:
