
# **Application Evaluation**



### Objection & Dispute Resolution > Progress

July 2013 – Expert Panels began delivering determinations


+ Over 65% of all objections have been resolved



### **Objection & Dispute Resolution > Outcomes**

September 2013 – ICANN began publishing determinations

- + Applicant prevailed in 86% of resolved, non-terminated cases







# **Registry Onboarding**

### Overview

- + Process to guide and support Registries through the start-up phase
  - Starts at Registry Agreement signing
  - Runs in parallel to PDT, Delegation, and Sunrise & Claims processes



- + Part 2: Credentialing and Operational Support Mechanism data collections
- + Eligibility Criteria required to obtain Delegation token



Step 1

- + Starts upon delegation
- + Establishes service infrastructures for registries
- + URS, ZFA, BRADA, RRI, SLA Monitoring
- + Contracting and Onboarding session



- + May start as early as Delegation
- + TLD Startup Information Collection and acceptance of Sunrise & Claims dates

#### Overview

+ EBEROs mitigate risks in the event a new TLD Operator fails

### **Key Highlights**



#### 150 hours to Transfer-in all 5 Critical Functions

#### **EBERO Providers**

- + 2 inspected and ready now: character and core
- + 2 in Contracting: **neustar** and **nominet**

### Data Escrow > Overview



### **Data Escrow**

- + 31 May 2013: First two ICANN-approved Data Escrow Agents announced
- + 28 June 2013: New gTLD Registry Data Escrow agreement templates published
- + Two Internet-Drafts define the format (XML/CSV):
  - http://tools.ietf.org/html/draft-arias-noguchi-registry-data-escrow
  - http://tools.ietf.org/html/draft-arias-noguchi-dnrd-objects-mapping
- + Going for RFC status after initial deployment and after gaining operation experience



# **Service Level Agreement Monitoring**

Ensures Registries provide baseline level of service in 5 critical functions

- + Operational Milestones:
  - October 2013: Domain Name System and Registration
    Data Directory Services testing
  - December 2013: Full Extensible Provisioning Protocol, Registration Data Directory Services, and Domain Name System testing

+ Monitoring platform in development by contractor

- 38 monitoring nodes for all ICANN regions
- 2 central processing locations



# Registry SLA Monitoring System Overview

+ A complex, real-time monitoring system used to determine whether a TLD is operating correctly Regional Nodes


Data

Centers

- + Validates that:
  - DNS is working
  - DNSSEC is working
  - The EPP interface is working
  - WHOIS is working
  - Updates in EPP are propagated to DNS & WHOIS

# **Registry Reporting Interface**

- + Aggregates information:
  - Data Escrow deposit notifications (daily)
  - Registry Operator reports (daily, monthly)
- + Generates alerts if data escrow is not performed per Contract
- + Loads input data for invoicing Registries and Registrars



- + Up to 50 abused labels associated with a verified trademark record
  - After validation, labels subject to the Claims process

  - Final version planned by March 2014 during ICANN 49


