ICANN's Open Data Initiative Framework

- ⦿ The **What** of the Open Data Initiative
 - Access to raw data through an open data platform
 - Engagement with the ICANN community through data sharing
 - Evidence-based decision making based on raw data and interpretation by the ICANN community
- ⦿ The **How** of the Open Data Initiative
 - Developing a technical strategy
 - Creation of a long-range plan for building data-sharing capacity
 - Developing a open data policy or playbook that makes the open data initiative operational and accountable to the community


Progress on the Open Data Framework for ICANN

- ⦿ Completed: The CEO's July 1st Goal
 - Göran established a strong, public commitment to opening data through his blog post on 10 May 2018
 - <https://www.icann.org/news/blog/icann-org-s-open-data-strategy>
- ⦿ (Nearly) Completed: The RFP to acquire a SaaS open data platform optimized to enable the reuse and dissemination of open data through non-proprietary formats
 - Final supplier selection is underway
- ⦿ Completed: Initial Data Asset Inventory (DAI)
 - This is a living document
- ⦿ Open: Public comment on open data artifacts currently open (11 June to 27 July)
 - Open Data Initiative Priorities
 - Open Data Initiative Datasets and Metadata

Next Steps: Open Data Portal and Policy

- ⦿ In Progress: Create a public data catalog **and** portal of all data sets that fall within the public disclosure classification policy per Engineering and Information Technology with oversight by Legal
- ⦿ In Progress: Establish an Internal Data Governance Model
 - **Open Data Long-range Plan:** The long-range plan makes the ICANN org and individuals accountable for moving the Open Data Program's mission and vision forward. The mission statement articulates the purpose for the Open Data Program's existence.
 - **Open Data Policy and Playbook:** This policy defines the responsibilities and expectations of the org and the Office of the Chief Technology Officer (OCTO) related to implementation of existing regulatory and emerging private, local and global practices for Open Data.
 - **Open Data Advisory Group:** The OCTO will convene an Open Data Advisory Group made up of org and community representatives to manage and guide the development of open data for ICANN.

Gantt: Open Data Portal and Policy



Timeline: Open Data Portal and Policy

- ⦿ **By the end of June 2018:** The selected solution for the open data portal will have a fully executed contract.
- ⦿ **By the end of June 2018:** The Open Data Policy to define the responsibilities and expectations of the org is completed.
- ⦿ **By the end of July 2018:** The long-range plan to make the ICANN org and individuals accountable for moving forward the Open Data Program's mission and vision is completed.
- ⦿ **By the end of August 2018:** The initial public data catalog **and** the first data sets are available on the open data platform.
- ⦿ **By the end of September 2018:** A calendar data set of data releases will be published on the open data portal
- ⦿ **By the end of October 2018:** The OCTO will convene an Open Data Advisory Group made up of org and community representatives.
