The question from the Board:

What collaborative actions should the Community, Board and Org be undertaking to further progress achieving our strategic priorities?"

Clarification on question from the board:

- "Strategic priorities" refer to the strategic objectives.
- "Our" is used in the context of the Strategic Plan.

The main idea is to have a long term perspective, what is next for us (ICANN Community) to do. How to get things done together.

In preparation the small group agreed:

- 1. To have an open dialogue around the different elements of the question and
- 2. The small group would like to know what other SO/ACs responded and how the input they gather from all the groups will be used.

Therefore, and taking into consideration what this small group discussed at the call, the topics to touch upon are:

- 1. Prioritization: Visualization of complexity and how to enhance processes.
  - 1. What are we doing specifically in the ccNSO.
  - 2. SOPC comments, the takeaways from the last plenary session on "Who sets ICANN's priorities" and Prioritization Framework.
  - 3. Efficiency: Things can be prepared in advance by ICANN and suggested to the community.
  - 4. Metrics: SOPC comments. To make progress one needs to measure, how is this envisioned can this be improved?
