So the RZERC was chartered to go and review any significant changes to the content of the root zone and how it's constructed and distributed. We're going through a rechartering process right now because we've been through five years after the original RZERC was formed. And according to the charter, we have to review the charter every five years. We'll talk about that in a little bit. Next slide.

Here are the members of the RZERC who were appointed by a collection of different organizations around ICANN. I will note that there's one, Peter Koch has I believe just ended his term on the RZERC and we'll be waiting another appointment. And then the Registry Stakeholder Group has just appointed [inaudible] in the room. So welcome to the RZERC, [inaudible]. Next slide.

So like I was saying before, the charter dictates that every five years, we conduct a charter review. We began that process in April. And we're getting close to the next phase, which I think if we go to the next slide, we can see where we are in the process. There's a paper that describes the process on the RZERC website, in correspondence to the Board.

We as a work party, we've just finished the first pass through the charter, reviewing it for potential changes. And we're drafting the document that will go to the Board with a discussion of any potential changes that we would request be made to our charter. It's not prepared right now. But we're expecting that we'll have it in a better shape and ready to present at the next ICANN meeting, ICANN 76.

That will also be accompanied with an ICANN public comment period that we hope to have right around the time that next ICANN meeting occurs. We'll review feedback from that and then send the final report to the Board.

Other than that, I think that's all of the major work we've done since the previous meeting last year at ICANN 72. I think that's it for what we have prepared for slides. The next one, I think it's up to questions. And that's all we have. for today. I'm happy to take any questions that anyone in the room has or even on Zoom.
