Challenges, Impacts, and Mitigations

Challenges

- Growing focus of governments and IGOs on the DNS including the tendency to attempt to address political or social challenges with technology "solutions"
- New regulations/legislation may not be DNS related, but could have negative unintended consequences on a stable globally interoperable Internet and on ICANN's activities and governance.
- Monitoring more frequent and more widely dispersed deliberations, discussions, legislative drafting with potential to impact the security stability and resilience of the DNS.

Impacts

- Changes could impact ICANN's ability to perform its mission
- Disruption of SSR of the Internet
- Political and/or reputational damage to ICANN

Mitigations

- Engagement (bilateral meetings, webinars, training, workshops, virtual events)
- Targeted messaging
- Analytic publications to inform the community
- Ecosystem Mapping to prioritize engagement and relationship management

Key issues at ITU PP-22

Internet related resolutions expected to be renegotiated

- Resolution 101: Internet Protocol-based networks
- Resolution 102: ITU's role with regard to international public policy issues pertaining to the Internet and the management of Internet resources, including domain names and addresses
- Resolution 130: Strengthening the role of ITU in building confidence and security in the use of information and communication technologies
- Resolution 133: Role of administrations of Member States in the management of internationalized (multilingual) domain names
- Resolution 180: Promoting deployment and adoption of IPv6 to facilitate the transition from IPv4 to IPv6





Legislative Developments



European Union

Closing legislative files

- The DSA will be approved in September and will be applicable around January 2024
- The NIS2 is expected to be approved in October, EU member states will have 21 months to transpose it



European Union

Other legislative files

- Proposed Regulations on Geographical Indications' (Gls)
- Al Regulation
- elDAS
- EU standardization strategy
- 'Fair share' discussion



APAC Developments: China

- Recently a number of new regulations/legislation with the potential to touch on ICANN's mission
 - Cybersecurity, Data Protection, Data Security, etc.
- The most notable with an impact to ICANN is the Personal Information Protection Law (PIPL)
 - Took effect on 1 Nov 2021
 - Similar to GDPR with some differences



APAC Developments: India

IT Act 2000, with amendments in 2008

- The Indian Government has been discussing an overhaul of the Act given new developments in the space
- Updates in the past two years:
 - The IT Rules 2021 was passed in Feb 2021 (superseding the IT Rules 2011 which formed part of the IT Act 2008).
 - "Directions on the IT Act 2000 sub-section (6) of section 70B" relating to information security practices, procedures, prevention, response, and reporting of cyber incidents, was published in Apr 2022.



APAC: Personal Data Protection Related Developments

- Thailand's Personal Data Protection Act
 - Took effect on 1 June 2022
- Japan's Amendments to the Protection of Personal Information Act
 - Took effect on 1 Apr 2022
- Sri Lanka's Personal Data Protection Act
 - Bill passed on 19 Mar 2022.
- Vietnam's Draft Personal Data Protection Decree (PDPD)
 - Final version pending
- Bangladesh's Personal Data Protection Bill
 - Still in draft mode
- India Data Protection Bill (2021)
 - Withdrawn



APAC: Other Internet-Related Regulations/Legislation

 Across the Southeast Asia sub-region, we're observing more regulations/legislation relating to overall management and use of the Internet.

Recent examples:

- Vietnam's New Draft for Decrees on Management, Provision, and Use of Internet Services and Online information; and on the Management and Use of the Internet
- Cambodia's Sub-Decree on National Internet Gateway.
- Oceania region
 - Search and Surveillance Act of 2012
 - Intelligence and Security Act of 2017
 - Cyber Security Strategy 2019
